CONTRACT AGREEMENT

THIS AGREEMENT made the 10th day of OCT 27 2021 2021 between NORTHWEST SAMAR STATE UNIVERSITY of Rueda Street, Calbayog City, Samar, Philippines (hereinafter called the "Entity") of the one part and HLYC TRADING of 1133e Aguilar Street, Sta. Cruz, Manila (hereinafter called the "Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the SUPPLY AND DELIVERY OF MACHINERY AND EQUIPMENT (Lot 1: Supply and Delivery of IT Equipment) with PR#2021-08-336 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of SEVEN MILLION FIVE HUNDRED TWENTY EIGHT THOUSAND SIX HUNDRED SEVENTEEN PESOS AND SIXTY CENTAVOS (Php7,528,617.60) (hereinafter called the "Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

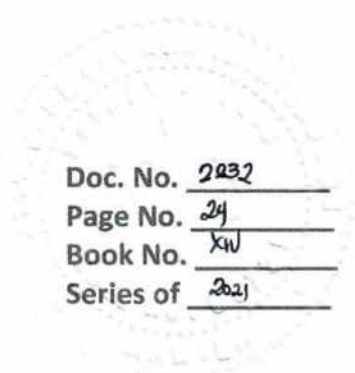
