

BAC RESOLUTION DECLARING METROGLOBAL SECURITY AGENCY INC. AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) AND RECOMMENDING TO NwSSU BOARD OF REGENTS TO AWARD THE CONTRACT FOR THE PROVISION OF SECURITY SERVICES FOR ONE (1) YEAR CONTRACT IN THE AMOUNT OF THREE MILLION FORTY FOUR THOUSAND TWO HUNDRED NINETY FOUR PESOS AND TWENTY EIGHT CENTAVOS (PHP 3,044,294.28)

WHEREAS, the Northwest Samar State University (NwSSU) has an Approved Budget for the Contract amounting to Three Million Three Hundred Eighteen Thousand Seven Hundred Fifty Pesos (Php 3,318,750.00) through Special Trust Fund for the "Provision of Security Services for One (1) Year Contract" of both Main and San Jorge Campuses;

WHEREAS, the Invitation to Bid (ITB) for the Provision of Security Services for One (1) Year Contract was posted on February 8, 2022 on PhilGEP5, NwSSU website, and three (3) conspicuous places at the NwSSU premises;

WHEREAS, in response to the said posting, only one (1) prospective bidder, namely, Metroglobal Security Agency Inc. purchased the bidding documents and submitted their bid on time;

WHEREAS, during the Opening of Bids on February 28, 2022, said bidder was qualified and passed the preliminary examination of bids;

WHEREAS, Section 36(a) of the Revised IRR provides that "A Single Calculated and Responsive Bid (SCRB) shall be considered for award if after advertisement, only one prospective bidder applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirement";

WHEREAS, the bid proposal of the lone bidder was found to be substantially complying:


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVED as it is hereby RESOLVED:
